- does not meet Career Readiness Standards, as documented on Form DD-2958, Service Member Career Readiness Standards/Individual Transition Plan, signed by my commander;
- is between 18 and 24 years of age; or
- is being involuntarily separated through a service reduction-in-force.

➤ **I am a wounded, ill or injured service member receiving treatment at a military treatment facility or warrior transition unit.**

➤ **I am the spouse or family caregiver of a wounded, ill or injured service member receiving treatment at a military treatment facility or warrior transition unit.**

IF ANY OF THE FOLLOWING APPLY TO YOU, PLEASE REVIEW THE BACK OF THIS CARD.

It is not necessary to identify which of these factors may apply to you—only inform staff if one or more of the factors does apply.

➤ **I am a veteran who:**

- served on active duty (excluding basic training) for more than 180 days and received other than a dishonorable discharge;
- was discharged/released from active duty because of a service-connected disability;
- is between 18 and 24 years of age; or
- was a member of a Reserve/National Guard component called to active duty; served during a period of war, or in a campaign, or expedition for which a campaign badge is authorized; or was released from active duty by reason of sole survivorship discharge.

➤ **I am a spouse of:**

- a veteran who died of a service-connected disability;
- a veteran who has a total disability rating from the Department of Veterans Affairs resulting from a service-connected disability;
- a veteran who died while a service-connected disability was in existence; or
- a veteran or an active duty service member who for more than 90 days is/was listed as:
 - missing in action;
 - captured in the line of duty by hostile forces; or
 - forcibly detained or interned in the line of duty by a foreign government or power.

➤ I:

- **separated from active duty within the last 3 years** and have been unemployed for 27 or more weeks in the previous 12 months;
- **am disabled** (entitled to compensation from the US Department of Veterans Affairs (VA), would be entitled to compensation except for receipt of military retired pay, has a disability claim pending with the VA, or discharged or released from active duty because of a service-connected disability);
- **do not have a high school diploma or GED ;**

- **am low income;**

- **am homeless or at risk of being homeless;**

- Homeless (per Section 103 McKinney-Vento): an individual who lacks a fixed, regular, and adequate nighttime residence or who has a nighttime residence that is a supervised shelter designed to provide temporary living accommodations (including welfare hotels, congregate shelters, and transitional housing for the mentally ill), an institution that provides a temporary residence for individuals intended to be institutionalized, or a public or private place not designed for, nor ordinarily used as, a regular sleeping accommodation for human beings;
- Near-homeless (per P.L. 111-22 added to Section 103): an individual who has an eviction notice requiring them to leave their housing (whether their own or housing they are sharing with others) within 14 days, who is staying in a hotel or motel not paid for by a government or charitable entity and lacks the resources that would allow them to remain in a hotel or motel for more than 14 days, or who has credible evidence that they would not be able to stay with another homeowner or renter for more than 14 days;

- **am fleeing or attempting to flee domestic violence;**

- **am an offender;**

- Offender (per Workforce Innovation and Opportunity Act §3(38)): an individual who is or has been subject to any stage of the criminal justice process and for whom services may be beneficial or who requires assistance in overcoming barriers to employment resulting from a record of arrest or conviction;
